Last year, FCF's SVP of corporate and social responsibility, Dr Ernesto Mendoza, and his wife were honoured at the international and prestigious Mining Journal awards ceremony in London, England, for their work in assisting the community at Runruno recover from the effects of Super

In August this year, FCF then became the latest recipient of the Kabalikat Award (Industry Category) for Region 2 by the Technical Education and Skills Development Authority (TESDA) for its outstanding skills development and training work with the Runruno Livelihood Foundation in Runruno, Quezon, Nueva Vizcaya.

And only last month during the Presidential Mineral Industry Environment Award (PMIEA) ceremonies at the 55th Annual Mine Safety and Environment Conference (ANMSEC), FCF received the Platinum Award (Exploration Category) in recognition of its exemplary performance in environmental management. In the same event, FCF's Runruno Project was also awarded 1st Runner Up (Exploration Category) in the Mining Forest Contest nationwide which is under the "Adopt-A-Mountain, Adopt-A-Mining Forest" program. The award was given based primarily on the nursery operations, extent of planted areas and their protection and maintenance within their exploration permit area. To date, FCF has potted 226,351 plants; has planted 42,119 plants with an average survival rate of 86% covering a total area of around twenty two hectares.

Gary Powell, director of FCF Minerals Corp., is elated at the significance of these awards to the company and the people that work tirelessly to make it successful. "It's very significant that we've got these awards," he says. "It shows that we have been recognized as a company that is trying to do its best for the environment and demonstrates our commitment to social

and environmental responsibility."

Even as they are called a "mining" company, FCF is actually more of an "exploration" company. With very limited funding and no revenue stream to speak of to fund corporate social responsibility (CSR) projects, they still recognize the importance of the commitment to environmental and social responsibilities. "When we raise money for exploration, we make sure we are raising enough money for looking after the community and

environment as well," Powell adds. FCF is owned byMetals Exploration Plc., a United Kingdom-based company, listed on the AIM board of the London Stock Exchange in October 2004, by Peter Draper and Powell who have both been resident in the Philippines for over 10 years. Draper, a former drilling company owner, had extensive knowledge of the various mineralized districts of the Philippines from carrying out drilling contracts, and Powell, a geologist, was previously managing director of an Australian company that had exploration projects in the country until the late 1990s. Since then, Powell has acted as a consultant to various companies operating in the Philippines, including

In a business that directly affects the natural environment and community of people it works in, a balance must be struck in order for the company to grow – and let the

elements that it touches to evolve with it. In that context it is worth highlighting the work done by FCF Minerals Corporation at its Runruno Project in Quezon Nueva Vizcava which has been attracting a series of awards and recognition both nationally internationally.

children aged five to six years). To date, there are nine (9) existing Day Care Centers within Runruno and all the Day Care Center facilities and teacher salaries in Runruno, are fully sponsored by the company. Enlisted malnourished kids in all these Day Care Centers also receive free snacks during their classes. Finally, RLF also subsidizes the salaries of seventeen (17) other Day Care Centers' teacher salaries within the town of Quezon. In the primary and intermediate levels, FCF fully sponsors nine (9) teacher salaries, and in the Secondary level, FCF fully sponsors ten (10) teacher salaries. The company also gives full scholarship to deserving students in the tertiary level. To date, there are three (3) students who are enjoying this privilege, and are enrolled in the following courses: BS Metallurgical Engineering, BS Mining Engineering and BS Geodetic Engineering. Lastly, the company also sponsors technical and vocational trainings.

The project is involved with a diverse range of community-based activities and is structured in such a way that each village has its own dedicated community adviser. Livelihood programs include the enhancement of skills of the local people and the use of natural materials in the area. The advisers concentrate on developing

the skills and confidence of the inhabitants of a particular area and each runs a clusterspecific production project such as a bakery, citrus processing operation, soft broom making, and agribusiness programs like pig, duck, goat, chicken dispersal as well as mushroom production, organic farming and fishpond project (tilapia). The company also financially assists in the acquisition and maintenance of basic infrastructures in the area: the building of three (3) hanging bridges, maintenance of road, potable water systems and irrigation systems, school construction materials and the building of barangay clinic.

Taking care of the environment, helping the community and running a successful company is a formula that has proven itself time and time again. All it takes is dedication, hard work and a clear-cut path to what you want people to see your company as. Powell notes that their awards and accolades are nothing if not for the tireless efforts of every single employee in their organization, "Even though we went up on stage and were presented the awards, we've actually accepted them on behalf of all the people that put the work in. We didn't really do the work because it was the guys on the ground who performed the tasks. We're very proud of the people who actually laboured and exerted all their efforts in doing an excellent job.'
